OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

1. The Scentsy's Your Magic Moment Sweepstakes ("Promotion") is sponsored by Scentsy, Inc. ("Sponsor"), 2701 E. Pine Avenue, Meridian, ID 83642, USA, and is administered by Prize Logic, LLC ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48076, USA.
2. **PROMOTION TIMING:** The Promotion begins on August 1, 2022 at 6:00 AM Pacific Time ("PT") and ends on September 15, 2022 at 11:59:59 PM PT ("Promotion Period"). The Administrator's computer is the Promotions' official clock.
3. **ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States (excluding US territories), the District of Columbia, and Canada only who are at least eighteen (18) years of age or the age of majority in their place, of residence at the time of entry (excluding Canadian territories). Employees, officers, directors, representatives, and agents of Sponsor, Administrator, Disney Worldwide Services, Inc. ("Disney") and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void where prohibited or restricted by law. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.
4. **HOW TO ENTER THE PROMOTION:** There are two (2) ways an entrant may access the Promotion (each a "Prize Pool"). Entrant may only register through one (1) of the following two (2) options. Upon completing the registration, entrant will not be able to register for the other Prize Pool.

Boxes not accepted), city, state, ZIP code, telephone number, date of birth (MM/DD/YYYY),

and the complete name of his/her Scentsy consultant, on a 3½”x5” card (“Mail-In Entry”) and mail it with sufficient postage to: Scentsy’s Your Magic Moment Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked no later than September 15, 2022, and received on or before September 23, 2022, in order to be eligible.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

- B. Register through Promotion Website (“Prize Pool 2”):** During the Promotion Period, an eligible entrant may visit <https://scentsy.com/sweepstakes> and follow the links and instructions to register for the Promotion.

After submitting the required information, entrant will automatically receive one (1) entry into the applicable Prize Pool. There is a limit of one (1) registration through option A or option B.

Upon registering for the Promotion, eligible entrants may receive additional entries into the applicable Prize Pool by completing the following activities:

For Opt-In: During the Promotion Period, an entrant may follow the links and instructions to opt-in to promotional emails from Sponsor and a Scentsy consultant (if applicable). Upon clicking the button to opt-in, entrant will receive ten (10) entries into the applicable Prize Pool. Entries will be awarded upon clicking the button so if an entrant has already opted-in, he/she will just need to click the button to receive ten (10) entries. An entrant may opt-out at any time by clicking on the unsubscribe link in the email received. This activity may be completed one (1) time during the registration process within the Promotion Period and cannot be revisited once registration is complete. If Sponsor’s internal records indicate that an entrant from “Prize Pool 2” has purchased Scentsy product from an active Scentsy Consultant, entrant contact information will be shared with the active Scentsy Consultant that the entrant most recently purchased product from, and that Scentsy Consultant may send the entrant promotional materials.

For Share Promotion on Facebook: During the Promotion Period, an entrant may obtain up to one hundred (100) additional entries by following the instructions on the website and set forth below to share the Promotion on Facebook. Upon clicking the buttons to share the Promotion, a message with a unique link will be posted to the entrant’s Facebook Wall (“Invitation Post”). To obtain additional entries, an entrant’s Facebook “Friend” must click on the unique link in the Invitation Post and complete and submit the registration information requested to enter the

Promotion. Upon the Friend's successful entry into the Promotion, the original entrant will receive ten (10) entries into the applicable Prize Pool. An entrant will receive ten (10) entries for each Friend who enters the Promotion by following the unique link in his/her Invitation Post, up to maximum of one hundred (100) additional entries through this method.

For Follow Scentsy on Instagram: During the Promotion Period, an entrant may click on the "Follow Scentsy on Instagram" button. Entrant will receive five (5) entries upon clicking the button. This activity may be completed one (1) time during the Promotion Period.

For Follow Scentsy Facebook Page: During the Promotion Period, an entrant may click on the "Follow Scentsy Facebook Page" button. Entrant will receive five (5) entries upon clicking the button. This activity may be completed one (1) time during the Promotion Period.

For Visit Scentsy Site Page: During the Promotion Period, an entrant may click on the "Explore Scentsy" button. Entrant will receive five (5) entries upon clicking the button. This activity may be completed one (1) time during the Promotion Period.

Limit: Regardless of the method of entry an entrant may register once and receive up to one hundred twenty-six (126) entries during the Promotion Period. An entrant will receive no more than the stated number of entries during the Promotion Period. If more than one registration or more than the stated number of entries is received from the same person, telephone number and/or e-mail address at any time during the Promotion Period, the entries may, at the Sponsor's sole discretion, be disqualified.

- 5. RANDOM DRAWING:** On or about September 26, 2022, Administrator will select the potential winners from among all eligible entries received in each Prize Pool, during the Promotion Period. There will be two (2) potential grand prize winners (1 for entrant and 1 for designated Scentsy consultant), and five (5) potential first prize winners in Prize Pool 1. There will be up to two (2) potential grand prize winners (1 for entrant and 1 if an entrant is tied to a Scentsy consultant, as determined by Sponsor in its sole discretion), and five (5) potential first prize winners in Prize Pool 2.

NOTE: If an entrant enters the Promotion through Prize Pool 2, and during winner verification it is determined that there is a Scentsy consultant associated with the entrant's account (determined by Sponsor in its sole discretion), then that Scentsy consultant will also receive a grand prize (pending verification). If there are multiple Scentsy consultants associated with an entrant, the eligible winner will be the Scentsy consultant that is associated with entrant's account based on the most recent purchase. Lastly, if there is no Scentsy consultant associated with an entrant's account, then only one (1) grand prize will be awarded for Prize Pool 2.

Each winner is deemed to be a potential winner, pending verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion. Canadian residents will be required to correctly answer a timed mathematical

skill-testing question as further described in Section 6 before being declared a potential winner and receive a prize.

6. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prizes (up to 4 total, 2 for Prize Pool 1 and up to 2 for Prize Pool 2): Each grand prize is a trip for up to four (4) persons to *Walt Disney World® Resort* (“Grand Prize”). Trips include round-trip coach class air transportation from a major commercial airport near winner’s residence to Orlando, FL for winner and up to three (3) guests, 5-nights’ accommodations at a Deluxe *Walt Disney World® Resort* hotel (selected by Sponsor in its sole discretion), four (4) 4-day theme park tickets with Park Hopper® Option, a \$500 Disney Gift Card (terms and conditions apply), one (1) Welcome Amenity (in-room gift), and a Scentsy product package (contents of package determined by Sponsor in its sole discretion and will be shipped to the address provided during registration). Details of each product and prize package will be determined by Sponsor in its sole discretion. No more than ten (10) First Place Prizes, five (5) per Prize Pool, will be awarded in the Promotion.

C. Total ARV: The total ARV of the prize available in this Promotion is \$37,315 USD / 47,783.72 CAD*

*All currency conversions based on listed exchange rate as of May 24, 2022.

D. Odds of Winning/Limit: The odds of winning a prize depend on the number of eligible entries received in each Prize Pool, during the Promotion Period. There is a limit of one (1) prize per person/household.

E. General Requirements: In order for a Scentsy consultant to be eligible to receive a grand prize he/she must be current and in good standing as outlined in the Consultant Scentsy Standards.

7. HOW TO CLAIM A PRIZE: Each potential winner will be notified via e-mail by Sponsor or its authorized designee at the e-mail address provided at the time of entry. Before being declared a Grand Prize winner, each Grand Prize potential winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”), if a US resident, or a

Declaration of Eligibility/Liability/Publicity Release, if a Canadian resident (“Declaration”), sent with the e-mail notification. If any potential winner is a Canadian resident, before being declared a winner, he/she will be required to correctly answer a timed mathematical skill-testing questions without assistance, which will be provided with the email notification or the prize will be forfeited. The potential Grand Prize winners must return a fully executed and notarized Affidavit/Declaration to the Sponsor or its authorized designee within ten (10) calendar days from the date it is postmarked as being sent to the potential winner or the prize may (in Sponsor’s sole discretion) be forfeited. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES**
